- The Government of Nepal has received financing from the Asian Development Bank (ADB) towards the cost of Earthquake Emergency Assistance Project (EEAP). Part of this financing will be used for payments under the contracts named below.
- The **Central Level Project Implementation Unit (CLPIU), Ministry of Education (MOE)** invites sealed bids from eligible bidders or joint ventures from eligible source countries of the ADB for the Construction of School buildings, Toilet and Water Supply facilities in 3(Three) schools in **Okhaldhunga** & 6(Six) schools (in two Package) in **Kavrepalanchowk** districts including site development works under National Competitive Bidding (NCB) procedure.

In addition, failure to provide (i) a complete technical proposal, and (ii) complete information to access the Bidder's qualification in accordance with Section 4 of the Bidding Document shall be ground for declaring the bid nonresponsive.**

Bids will be opened immediately after the deadline for bid submission in the presence of bidders' representatives who choose to attend.
