The **Central Level Project Implementation Unit (Education), National Reconstruction Authority (NRA)** invites sealed bids from eligible bidders or joint ventures from eligible source countries of the ADB for the Construction of School buildings, Toilet and Water Supply facilities including site development works in 8 (Eight) schools in single package of **Okhaldhunga** District.
