1. The Government of Nepal (GoN) has received a loan from **Japan International Cooperation Agency (JICA)** towards the cost of **Emergency School Reconstruction Project (ESRP)**. It is intended that part of the proceeds of this loan will be applied to eligible payments under the Contract for **Construction of School Buildings Batch-1** as mentioned below.

The **Central Level Project Implementation Unit (CLPIU), Ministry of Education (MoE)** now invites sealed Bids or electronic bids from eligible Bidders for the construction and completion of **School buildings (the Works)** under National Competitive Bidding (NCB) procedure. Only eligible bidders with the following key qualifications should participate in this bidding:

2. Interested eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **CLPIU, Gyaneshwor, Kathmandu (Tel No: 4420106)** and may visit the e-procurement PPMO's Web Site **www.bolpatra.gov.np**.

A complete set of Bidding Documents may be purchased by interested Bidders on the submission of a written application to the address above, along with a copy of company/firm registration certificate valid for the Fiscal Year 2072/73 and a copy of the income-tax clearance certificate for the Fiscal Year 2071/72, and upon payment of a non-refundable fee **as given below** on or before 30th day of date of publication of this notice (i.e. **December 22, 2016**). Bidders can inspect detail drawings in the CLPIU office.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site **www.bolpatra.gov.np**. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. A pre-bid meeting shall be held at the office of CLPIU, Gyaneshwor, Kathmandu at **11:00 hours on December 14, 2016**.

Bids shall be subjected to post qualification criteria including minimum average annual turnover, experience in similar works, minimum number of essential equipment, qualification and experience of key personnel, minimum amount of liquid asset and or credit facilities as specified in the bidding documents.
6. Sealed Bids must be submitted to the Project Director, CLPIU, MoE indicating contract identification number, name of the contract, name of the bidder's firm and its address on or before 12:00 hours, December 23, 2016 and must be accompanied by a bid security of amount as given above. Bids received after this deadline will be rejected. Alternatively, interested eligible bidders may visit e-procurement section of PPMO's Web Site **www.bolpatra.gov.np** and submit their bids electronically as instructed in the Bid Document.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on December 23, 2016** in **CLPIU, Gyaneshwor, Kathmandu**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security as mentioned above, which shall be valid for **30 days** beyond the validity period of the bid (i.e. **April 21, 2017**).
8. If the last date of purchasing, submission, opening of the bids or that of the pre-bid meeting falls on a government holiday, it shall be extended to the next working day.
9. The Employer reserves the right to accept or reject any or all of the bids without assigning reason, whatsoever.
10. Any conditions so far not covered shall be as per Public Procurement Act-2063 and Public Procurement Regulations-2064.
