5. To purchase the Bidding Documents in English, eligible bidders should write to the address above requesting the Bidding Documents for EEAP/MOE/CLPIU/Vehicles/073/74-01, Supply and delivery of 4WD hard top vehicle (Jeep) should pay a nonrefundable fee of NRs 3000.00 (NRs Three thousands) by cash.
6. Deliver your bid to the address above on or before the deadline: **16 March 2017 at 12:00 hour** together with a Bid Security of NRs 560,000.00 (NRs five hundred sixty thousands) valid for 90 days as described in the Bidding Document. Bids will be opened immediately after the deadline for bid submission in the presence of bidders' representatives who choose to attend.
7. In case the day of Bid submission falls on a public holiday, the Bid submission date shall be the following working day.
8. The **Ministry of Education (MOE), Central Level Project Implementation Unit (CLPIU)** will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
