1. The Government of Nepal has received financing from the Asian Development Bank (ADB) towards the cost of Earthquake Emergency Assistance Project (EEAP). Part of this financing will be used for payments under the contracts named below.
2. The **Central Level Project Implementation Unit (CLPIU), Ministry of Education (MOE)** invites sealed bids from eligible bidders or joint ventures from eligible source countries of the ADB for the Construction of School buildings, Toilet and Water Supply facilities in 9(Nine) schools (three package) in **Okhaldhunga** district including site development works under National Competitive Bidding (NCB) procedure.
3. Only eligible bidders with the following key qualifications should participate in the bidding:

- Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Bidders are required to specify the total price of bid in the letter of price Bid or the Bid price in the summary of Bill of Quantities. **Failure to specify the total price of the Bid in Letter of Price Bid or Bid Price in the Summary of Bill of Quantities shall be ground for declaring the bid nonresponsive. In addition, failure to provide (i) a complete technical proposal, and (ii) complete information to access the Bidder's qualification in accordance with Section 4 of the Bidding Document shall be ground for declaring the bid nonresponsive.**

Bids will be opened immediately after the deadline for bid submission in the presence of bidders' representatives who choose to attend.
