- Government of Nepal has received a loan/credit/grant from Japan International Cooperation Agency (JICA) towards the cost of Emergency School Reconstruction Project (ESRP) and intends to apply part of the funds to cover eligible payments under the Contract for Fabrication, Supply and Delivery of School Furniture as mentioned below. Bidding is open to all eligible Bidders from all countries as defined in JICA Procurement Guideline.
- 2. The Central Level Project Implementation Unit (CLPIU), Ministry of Education (MOE) invites sealed bids from eligible bidders for the procurement of Fabrication, Supply and Delivery of School Furniture as mentioned in Bill of Quantities (BOQ).
- 3. Interested eligible Bidders may obtain further information and inspect the Bidding Documents at the office of CLPIU, Gyaneshwor, Kathmandu, (Phone +977 1 4420106) and may visit the e-procurement PPMO's Web Site www.bolpatra.gov.np.

A complete set of Bidding Documents may be purchased by interested Bidders on the submission of a written application to the address above, along with a copy of company/firm registration certificate valid for the Fiscal Year 2073/74 and a copy of the income-tax clearance certificate for the Fiscal Year 2072/73, and upon payment of a non-refundable fee as given below on or before 30th day of date of publication of this notice (i.e. March 23, 2017). Bidders can inspect detail drawings in the CLPIU office.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 5. A pre-bid meeting shall be held at CLPIU/MOE, Gyaneshwor, Kathmandu at 11:00 hours on March 13, 2017.
- 6. Sealed Bids must be submitted to the **Project Director**, **CLPIU**, *MOE*, *Gyaneshwor*, *Kathmandu* on or before 12:00 hours on 24 March, 2017. Documents received after this deadline shall not be accepted.
- 7. Bids shall be opened in the presence of Bidders' representatives who choose to attend 13:00 hours 24 March 2017 at the office of CLPIU, MOE, Gyaneshwor, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum mentioned as above, which shall be valid for minimum 30 days beyond the bid validity period (i.e. July 23, 2017).
- 8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
- 10. Any conditions so far not covered shall be as per Public Procurement Act-2063 and Public Procurement Regulations-2064.
