1. *The Government of Nepal [GoN] has allocated funds from GoN towards the cost of Construction of School Building in Chhorepatan Secondary School, Pokhara Metropolitan City, Kaski District (having 2000+ students) and intends to apply part of the funds to cover eligible payments under the Contract for Construction of School Building in Chhorepatan Secondary School, Pokhara Metropolitan City, Kaski District (having 2000+ students), Contract Id No.: MoEST/CLPIU/GoN/Works/2082-083/NCB-06. Bidding is open to all eligible as per Section V of bidding document.*
2. *Central Level Project Implementation Unit (CLPIU), Sanothimi, Bhaktapur invites sealed bids or electronic bids from eligible bidders for the construction of School Building in Chhorepatan Secondary School, Pokhara Metropolitan City, Kaski District (having 2000+ students) under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.*

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 52 million**
 - Minimum Work experience of similar size and nature: **One RCC Frame Structure Building Construction project of Value NRs 20.8 million**
3. Bidder can download and submit their bid through PPMO's e-GP system www.bolpatra.gov.np/egp only. Bidders who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

6. Pre-bid meeting shall be held at **Central Level Project Implementation Unit (CLPIU), Sanothimi, Bhaktapur at 12:00 hours on 07 July 2026.**
7. Sealed or electronic bids must be submitted to the office **Central Level Project Implementation**

Unit (CLPIU), Sanothimi, Bhaktapur through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hours on 17 July 2026**. Bids received after this deadline will be rejected.

8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **12:30 hours on 17 July 2026** at the office of **Central Level Project Implementation Unit (CLPIU), Sanothimi, Bhaktapur**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs **1.7 million**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
